### Member's Declaration

I declare that I will maintain a Policy of Insurance that will provide an Indemnity to Third Parties for an amount of not less than £3,000,000 in respect of my boat(s) whilst on the Club premises or Club water. I further declare that I will ensure that my boat(s) has / have adequate buoyancy when sailed on the Club water.

Where I am the Parent or Guardian of the Cadet(s) under the age of 16 years that are part of my membership and listed below I accept full responsibility for their conduct and safety while taking part in Club activities.

Papercourt Sailing Club retains personal data of all members purely for the purposes of club membership and in accordance with data protection legislation and requirements. By signing this declaration you agree to PSC holding your personal data and those on the membership application. This data will not be shared with any person or company who is not a member of the club without your written permission and consent. I consent to the Club taking and using my photograph for club internet and social media use.

I (and my family) agree to become a member(s) of Papercourt Sailing Club Ltd and acknowledge the related Articles of Association and Byelaws of the Club (displayed in the clubhouse). I/we confirm my/our understanding and acceptance that such documents (as amended from time to time) shall govern my/our membership of the Club and that being a company limited by guarantee I accept my liability for £1.00 and the £1.00 liability for each family member aged over 16. 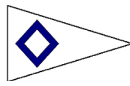

## Statement of Risk

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the sailing, each participant agrees and acknowledges that:

- they are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- they are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- they accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- their boat is in good order, equipped to sail in the event and they are fit to participate;
- the provision of a race management team, trainers, patrol boats and other officials and volunteers by the organiser does not relieve them of their own responsibilities;
- the provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- it is their responsibility to familiarise themselves with any risks specific to this venue or event and to attend any safety briefing held at the venue.
