### Notes:

1. A **FAMILY Membership** consists of a family group of 2 sailing adults (generally Husband/Wife or co-habiting partners) and any number of their children under the age of 18, or if in full-time education under the age of 26. The Committee has the discretion to determine what constitutes a family group.
2. **ALL CHILDREN** under the age of 16 must be members of either a FAMILY or SINGLE PARENT FAMILY Membership.
3. An **INDIVIDUAL Membership** consists of a single sailing adult member.
4. A **1 SAILOR FAMILY Membership** constitutes 2 adults (no children) who make up a family group and where 1 adult is a non – sailing member.
5. A **SINGLE PARENT FAMILY Membership** constitutes 1 adult and their child(ren) under the age of 18, or, if in full time education, 26 and is limited to *single parent families*.
6. A **CADET Membership** constitutes a member aged 16 to 18.
7. A **FULL-TIME STUDENT Membership** constitutes an adult member in full time education and under the age of 26.
8. A **COUNTRY FAMILY Membership** constitutes 2 adults who make up a family group and who live more than 50 miles from the Club.
9. A **COUNTRY INDIVIDUAL Membership** constitutes a single adult who lives more than 50 miles from the Club. Country class members have no sailing or berthing rights.
10. A **SOCIAL FAMILY Membership** constitutes 2 adult, non –sailing members.
11. A **SOCIAL INDIVIDUAL Membership** constitutes a single non – sailing member. Social class members have no sailing or berthing rights.
12. A **WINTER INDIVIDUAL (or FAMILY) Membership** constitutes a single adult member (or family group) who receive full membership during the winter sailing season (1st Nov to 31st Mar). The fee includes a single boat licence for the period. Winter members have no voting rights and joining is subject to simple election by the Committee.
